Furthermore, you consent to the processing of this data to request registered keeper details from the DVLA, where the Parking Contract is not adhered to and enforcement is undertaken by the ANPR cameras and/or by the attendants. Parking Charges incurred, as well as notified to the registered keeper by post, where the ANPR system identifies non-compliance with the Parking Contract, and may be re-issued to the relevant driver on receipt of the driver's valid name and address; or b) will be notified to the driver, where an attendant identifies non-compliance with the Parking Contract, and may subsequently be notified to the registered keeper. Personal data may also be shared with the BPA, PCPSA, email service providers, credit reference agents, collection agents or solicitors for this purpose and any authorised sub-contractors. A reduction of at least 40% of the Parking Charge will be available for a period of 14 days. Failure to pay the Parking Charge within this period will result in the full amount becoming payable. Where Parking Charges remain unpaid beyond 28 days, recovery charges in respect of further action may apply. A charge reflecting the costs ParkingEye may apply for payments made with a credit/debit card.
